  - Subject to the condition of full observance and compliance with the terms and conditions as set out in this Side Letter by the Purchaser(s), the PASP and the ASP on the part of the Purchaser(s), the Vendor will first invite the Purchaser(s) to apply for the purchase of <u>one (1)</u> Residential Parking Space at such location and at such price determined by the Vendor at its discretion.
